051/19 Local Elections 2019

The Clerk reported that 12 candidates had come forward and, as there are only 11 places on the council, a Parish Council election has been triggered which will take place on 2nd May 2019.

The Clerk reminded members that their election expense forms needed to be completed and returned to the Returning Officer at BDC by 31 May 2019, even if it is a nil return.

052/19 Proposed Community Garden The Clerk reported that the Lottery Grant application had been successful. In terms of the proposed site, BDC would like further clarification as to how the Parish Council would like to hold the land. There are a number of possible options including a permanent transfer or a leasing agreement. It was agreed to arrange a meeting with BDC to understand the cost implications and consider the terms of any agreement.

053/19 Faults and Repairs

The following reports and repairs were reported.

- Another complaint had been received about the lack of a stile/kissing gate on the footpath off Millbaulk Road. Clerk to chase again.
- One of the trees on Fountain Hill had been crushed by a car. Cllr. Howard has managed to prop it up but it is unlikely to survive. It was agreed to look at the purchase of replacement trees and other tree works in the autumn.
- Cllr. Vessey reported that she had observed what look like a number of officials inspecting the bus shelter near Newall's Terrace. The Clerk commented that she had reported what appeared to be loose/damaged tiles on the roof. Clerk agreed to enquire about the outcome of the inspection.
- The dyke downstream from the junction of South Moor Road and the High Street is now dry. This could be attributed to the hole in the dyke bottom near to the road junction. Clerk to chase to lan Davies, the BDC Drainage Engineer to ascertain what action has been taken/is planned since this was reported some months ago.
