

REPORTED CRIMES OF INTEREST FOR THE BASSETLAW EAST EVERTON/ BECKINGHAM BEAT AREA – SEPTEMBER 2020.

The Everton/ Beckingham beat area includes the following villages and hamlets – Misson, Misson Springs, Newington, Scaftworth, Harwell, Everton, Gringley on the Hill, Walkeringham, Saundby and Beckingham.

The crimes of interest – incidents of burglary, criminal damage and thefts – reported for the beat area between 01/09/2020 and 30/09/2020 were –

Burglary Dwelling – 1 (Everton).

Burglary Other – 1 (Everton).

Theft of Motor Vehicle – 1 (Everton).

Theft from Motor Vehicle – 2 (Scaftworth, Drakeholes).

Criminal Damage Other – 2 (Everton, Gringley on the Hill).

This month there have been seven reported crimes of interest across the whole beat area. This compares with seven crimes reported throughout August 2020 and two crimes in the same month last year.

From 01/04/2020, there have been thirty eight crimes of interest reported across the beat area. This compares with fifty one reported in the same period last year. As such, at the conclusion of the sixth month of this tracking year, these figures equate to a decrease in reported crimes of interest of thirteen crimes.

Please continue to report crime - and incidents - through to our control room on 101, or 999 as appropriate. Even in these most difficult of times, where possible, reported crimes will be dealt with in the same way as they have always been recorded, and dealt with. Please remain aware of any suspicious persons, vehicles and activity in the area and continue to report such instances through to our control room, as normal.

Nottinghamshire Police have recently started using a new system for recording incidents. As from February 2020, the Police report will include anti-social behaviour incidents only, negating other incident types from this category, such as hoax calls to the emergency services, found/ abandoned vehicles and wildlife/ animal issues. Again, these figures should, therefore, start to decrease but will be more accurate in relation to actual anti-social behaviour incidents on the area. This month there

have been four reported incidents of anti-social behaviour across the whole beat area. This compares with five reported incidents for August 2020 and six reported for the same month in 2019.

Many farmers have completed, or have just about completed, their harvesting. This, however, does make many farmers fields accessible again to vehicles being driven by wildlife criminals. Not only are wildlife at risk from this activity, but farmers and landowners also suffered due to damage caused to their land and crops. Please continue to report sightings of this type of activity to our control room and, certainly, in instances where the offenders are still at the scene, or have just left, a 999 call would be preferable to a 101 one.

As another year draws to a close, and Halloween/ Mischievous Night and Bonfire Night approaches, it would be a good time to remind everyone of the rules and regulations associated with the use and possession of fireworks. Whilst it would appear highly likely that public displays will not be allowed this year, the rules below are needed to be adhered to by us all. Every year the Police get numerous complaints about the misuse of fireworks and, as we know, people are still maimed and killed by their misuse.

On the flipside, for this beat area, over the last few years we have received very few complaints relating to the use and abuse of fireworks.

**The Fireworks Act 2003 put in place the Firework Regulations 2004. Regulation 4 makes it an offence for any person under the age of 18 to possess any firework in a public place or any place to where the public have access (except indoor fireworks such as cap, cracker snap, novelty match, party popper, serpent, sparkler or throw down).**

**Regulation 5 prohibits any person from possessing a category 4 firework, whether in a public place or not. Regulation 7 creates a curfew on the use of fireworks between the hours of 11 pm and 7 am with the following exceptions –**

- (a) Chinese New Year 1 am (the following day) to 7 am.**
- (b) 5<sup>th</sup> November 12 midnight to 7 am.**
- (c) Diwali 1 am (the following day) to 7 am.**
- (d) 31<sup>st</sup> December 1 am (the following day) to 7 am.**

**Regulation 9 states that no person will supply fireworks to the general public outside the following periods, unless they hold the appropriate license –**

**4 days before and including the day of Diwali.**

**4 days before and including the day of the Chinese New Year.**

**6 days before the 31<sup>st</sup> December.**

**3 weeks before and 5 days after the 5<sup>th</sup> November.**

**Please do not use these telephone numbers to report incidents and/ or crimes. Our works numbers should only be used for non-urgent matters – including seeking advice and/ or information.**

**I continue to receive calls on my works phone from residents wising to report incidents and crimes. In many cases these calls are received when I am on rest days or annual leave and have not got my works phone to hand. Residents must be comfortable in reporting these occurrences to our control room on 101 in order to receive the best, and real time, service from those officers who are on duty.**

**When ringing 101 the first item which is asked is which Police force you require. This is because 101 is the non-urgent number for all Police forces throughout the country and the signal is picked up from where you are ringing from. In rural East Bassetlaw many parishes are located close to county boundaries, hence the first question. Then, you are asked if you know the person or extension number of the department you require. At this stage, just hold the line. After this, there are a number of options available. For reporting an incident or crime the option is option 7 – there is no need to listen to all the alternatives before selecting this option number.**
