Government Broadband Gigabit Scheme

Cllr. Heath reported that Openreach have responded with a proposal to provide service to all 522 properties in the village (rather than the c.170 we submitted to them) and also an alternative, lesser, proposal for 375 properties. Both proposals include all respondents to our canvassing of interest. There are a few addresses with outstanding address queries which we are waiting for Openreach to respond on. Also there is a need to loop-back to Openreach to better understand the two proposals with the aim to select one of them at the next PC meeting.

Promotion of the Neighbourhood Plan Referendum on 6th May 2021

Resolved: to purchase 6 notices advertising the Referendum to be placed in prominent places around the village. Clerk advised that it is required by the Electoral Commission that the printer and promoter details are displayed on the signs.

New Dog Litter Bin

A request had been received from a resident requesting that a new dog litter bin be installed somewhere along Fountain Hill. Cllr. Sanger agreed to make a request to the BDC Cleansing Team. A suggested suitable location would be near the flower trough on the junction of Fountain Hill and Fountain Hill Road.

Dyke Maintenance Contract 2020/1

The Clerk reported that the Drainage Board had finally given some indication of the costs for dyke clearing for 2020/1. The total final bill has been calculated at around £4.9K. The Operations Manager was aware of some additional work including an emergency call out to a blocked culvert and commented that the work was more onerous than originally estimated. No previous indication had been given by the Board that the costs would likely to be significantly higher than those given in their tender. The Clerk had requested a further breakdown of how these costs had accumulated, complete with detailed narratives. This information has not yet been forthcoming.
